



Time Allocation

1.2.4 Secondary Level (grades 10 to 12)

At the secondary level, there are three categories in which students must obtain credits:

- required courses of study which are compulsory courses intended to provide a general education;
- **specified areas of study** which are intended to allow students to continue to take courses of a general nature or to specialize in areas of individual interest; and,
- electives which allow for further choice and specialization based on individual needs and local priorities.

Renewal Options

Appropriate professional development activities related to the subject area at the Grade 12 level which may be substituted for the renewal seminar include:

- A full-credit university course (minimum of 3 hours) that may be used toward a certificate, second degree or Master's degree in the subject area.
- Equivalent service* on a provincial or division curriculum committee in the subject area or a committee in the area of student evaluation, school-based program evaluation or curriculum evaluation.
- Equivalent service* as a pilot teacher for a new curriculum in the subject area.
- Equivalent service* in the development of provincial examinations as a setter, validator or subexaminer in the subject area.
- Equivalent service* in any one or a combination of the following:
 - active involvement in the professional development activities of a Special Subject Council
 in the subject area;
 - completion of non-credit courses or conference participation on student evaluation or program evaluation related to the subject area;
 - development and implementation of a personal professional development plan which might include reading, professional writing, research or presentations in the subject area; and,
 - involvement as a cooperating teacher in a secondary teacher education internship or extended practicum may form part of this plan.
- The accredited teacher may elect for students to write provincial examinations to meet the renewal requirements.

^{* &}quot;Equivalent service" is to be determined in terms of those activities which would serve to meet the objectives of the STF Accreditation Renewal Seminar.





English Language Arts Placement

- English as an Additional Language (EAL)
 - granted for credits in English, Ingles, Anglais etc.
 - students transferring from non-English speaking (non-first language English students) countries.
- Saskatchewan schools, and/or school divisions test for English proficiency to determine proficiency level for EAL supports that may be required.
- If testing results in a high benchmark English proficiency, the school can:
 - recommend the student be granted English Language Arts (in place of EAL) as a resulting high level of English proficiency
 - send an email to credit.transfer@gov.sk.ca
